1. To adopt the 2020 town tax levy to be paid in 2021 pursuant to Section 60:10(1) (a) of Wisconsin Statutes.
2. Authorize the town board to hire town officers as employees of the town in an emergency and set an hourly wage pursuant to Sec. 60.10(1) (g) of Wisconsin Statutes.
3. Compensation of Elected Officials pursuant to Section 60.32(1) of Wisconsin Statutes.
