Roads, roads, roads...

Tower Road Bridge, located between 87th and 90th Streets is being reconstructed this fall. Portage County Highway Department's Bridge/Culvert Aid program will provide \$121,891 to the Town; 50% of the costs for: design, soil borings, inspection and construction oversight, bridge foundation, structure and road reconstruction. Design services were provided by Jewell Associates Engineers, Inc. (Wisconsin Rapids). The construction award went to Pheifer Brothers Construction Co, Inc. (Neenah).

Joint and crack-sealing occurred on the following roads: 100th Street (CTH FF - Elm), 100th Street (Mill – Quarry, 90th Street (Pine – Lake), Angle (110th – Birch, Griffith (CTH U – 90th), Larry's Court, Mill Road (CTH U – 90th), Ryan's Way, and White Pine Drive (CTH U – Deer). The contractor on this work was Fahrner Asphalt and Sealing, Inc. Warranty work has yet to be completed on 110th Street (Deer – Lake), Deer (86th – 90th) and Griffith (110th – termini) from last year's chip seal projects.

Similar to work done on Grant Street (110th – CTH F) last year, whole scale tree removal occurred on 110th Street south of CTH W past Quarry Road this summer. Zblewski Brothers was the contractor. Our town crew will restore ditches and rebuild this section of road. This will be followed by an application of 3-4" of 3/4" gravel base with limited granite top-dressing on the north end. Similar work is slated for 87th Street (Tower – Evergreen).

In 2014, bridge/culvert inspections conducted by Portage County Highway Department staff identified the need to replace four (4) culverts on Evergreen where it crosses Ten Mile Creek. Fifty percent (50%) cost-share from the county will be available to complete this project in 2016. Culvert crossings over Buena Vista and Four Mile Creeks on 95th, 100th and 110th were found to have failing pavement, inadequate guardrails, and loss of wall integrity abutting the culvert pipes. Thankfully, the culvert pipes have retained their integrity through the years. The Town Board is considering extending the existing culvert pipes, adding rip-rap, and reconstructing these road sections next year. Cost-share options will be explored. Wetland determinations must first be completed to be in compliance with current Wisconsin DNR and US Army Corp regulations.

Restoration of Townline Road (CTH W south to drainage ditch) was completed this summer. This, following mistakes the Town made regarding conditions of a WDNR General Wetland permit. Quest Engineering LLC (Wisconsin Rapids) prepared the restoration plan and oversaw the project work. The contractor was ConsTrucks (Stevens Point). They regraded ditches, extended culverts, repaired fence and hydro-seeded.

In August the Wisconsin Department of Transportation (WisDOT) made a decision regarding the junction of CTH U (80th Street) and STH 54. They will install J-turns next year. This decision was a disappointment to the public officials who opted for an expanded median (similar to those on the newest section of CTH 10). Snow from your driveway(s) cannot be plowed across or placed directly onto a town road. Snow left perpendicular to the road can harden, creating an obstruction that may cause injury to persons, vehicles, and Town snow removal equipment. This is a violation of Wisconsin Statutes affecting town roads and can carry a fine of up to \$50 per occurrence. To avoid a fine please refrain from plowing across or placing snow directly onto a town road.

Lot Averaging

Are you thinking about splitting a parcel? If so, you might want to consider <u>lot averaging</u>. Persons who use this option do not have to comply with current minimum lot size requirements. Instead, smaller divisions are clustered together to retain as much open space as possible. For example, a 40 acre single parcel might be divided into four parcels – three two (2) acre home sites secured next to 34 acres. This larger parcel can be retained for farming, woodlands, or other large lot needs. Why buy a dog license? According to Wis. State Statute 174.05 all dogs over the age of 5 months must be licensed. The cost for a license is \$7.00 if the dog is spayed or neutered; otherwise \$17.00. After March 31st there is a \$10.00 late fee. The license is good for one year and expires on December 31. As of January 1st of every year, a new license is required to be purchased. The fees collected defray the cost of the contract that the Town has with the Humane Society of Portage County.

Sometimes dogs stray from home...having a tag helps them find their way back home to you! In the past, calls have been received from residents who were looking for the owners of dogs that had appeared in their yard. All dogs had tags so it was easy to look up the numbers and find their owners.

If you own a dog, or have renters that own a dog, I'd like to take this opportunity to share an important message about Dog Licensing (Landlords, we rely on you to inform your renters on the dog license requirements!)

State Law 174-05, Portage County Animal Control Ordinance, and Town of Grant Dog Ordinance **REQUIRE EVERY DOG** OVER THE AGE OF 5 MONTHS TO BE LICENSED. **CURRENT LICENSES EXPIRE DECEMBER 31, 2014.**

FAILURE TO OBTAIN A LICENSE OR HAVE A DOG VACCINATED AGAINST RABIES IS \$169.00 to \$263.50. The Town of Grant works closely with Portage County Humane Society (agency responsible for the enforcement of animal control) to ensue compliance of the laws.

For each dog at your residence being licensed you must provide (either send or bring to me) a copy of the current rabies certificate. If you are sending for a license, you must include the following items or a license will not be mailed:

- 1. Rabies Certificate with dates and Serum Number (if your dog is currently licensed and the shots are still in effect) you do not have to send #1 or #2 because they should already be in my computer.)
- 2. Proof of dog being neutered or spayed.
- 3. Fees (see below) [Note: Late fee of \$10.00 per dog for application after April 1, 2015].

Mailbox Installation

Place your mailbox according to the diagram shown below. There are two key aspects of the installation:

- 1. Face of mailbox is directly over the edge of shoulder
- 2. The suggested mounting height to 41-45". Refer to:

https://www.usps.com/manage/mailboxes.htm

If the face is aligned over the edge of shoulder gravel this allows us to clear snow and bench it back from the main traveled roadway and shoulders. This also allows your mail carrier to keep at least one set of tires on a surface that provides traction. In the case of an all gravel, granite, or sand roadway, this edge is defined where the road material meets the grass line.

Your cooperation with these installation details would be greatly appreciated by both the Town Board and the US Postal Service. Thank you!
