
Section 1-12 (b) to add the following:

7. Other concerns deemed significant by the Town Board affecting the health, safety or welfare of persons in the establishment



An Ordinance Prohibiting Issuance
of Alcohol Beverage Licenses For
Nonpayment of Taxes, Assessments and Claims

THE [COMMON COUNCIL/VILLAGE BOARD/TOWN BOARD] OF THE [CITY/VILLAGE/TOWN] OF
Grant, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. Section 12. ___ of chapter 12, relating to the regulation of
alcohol beverages, of the code of ordinances of Town of Grant, Wisconsin, is
created to read as follows:

12. ___ LICENSE RESTRICTIONS. (1) DELINQUENT TAXES, ASSESSMENTS, ETC.

(a) Premises. No initial or renewal alcohol beverage license shall be granted
for any premises for which taxes, assessments or other claims fo the [City/
Village/Town] are delinquent and unpaid.

(b) Persons. No initial or renewal alcohol license shall be granted to any
person:

1. Delinquent in payment of any taxes, assessments or other claims owed to
the [City/Village/Town].

2. Delinquent in payment of a forfeiture resulting from a violation of any
ordinance of the [City/Village/Town].

3. Delinquent in payment to the state of any state taxes owed.

Section 2. This ordinance shall take effect upon passage and publication as
provided by law.
