

**TOWN OF GRANT
ORDINANCE RELATING TO
UTILITY ACCOMMODATION
NO. 2012-02**

The Town Board of Supervisors of the Town of Grant, Portage County,
Wisconsin does ordain as follows:

SECTION 1 - ADOPTION OF UTILITY ACCOMMODATION POLICY

Pursuant to Sections 86.07(2), 86.16, and 182.017, Wis. Stats., the Town Board does hereby ordain and adopt the attached Utility Accommodation Policy No. 2012-01 incorporated in its entirety by reference.

SECTION 2 - PENALTIES FOR VIOLATION OF ORDINANCE

Any personal entity violating any provision of the Utility Accommodation Policy No. 2012-01 ordained by this Ordinance, shall upon conviction thereof forfeit not less than \$50 nor more than \$500 for each offense, together with the cost of prosecution. Each day of violation shall constitute a separate offense. The Town Board or any supervisor of such Town Board is hereby empowered to draft and issue a citation pursuant to the Town Of Grant Ordinance Relating To Issuance Of Citations For Violations Of Town Ordinances, No. 530-2008. Further, the Town Board may commence an action at law or in equity to seek legal or equitable relief for any violation of Utility Accommodation Policy No. 2012-01.

SECTION 3 - AMENDMENT OF ORDINANCE RELATING TO ISSUANCE OF CITATIONS FOR VIOLATION OF TOWN ORDINANCES, NO. 530-2008

Section 3 of the Ordinance Relating to Issuance of Citations for Violation of Town Ordinances, No. 530-2008 is hereby amended by adding to such Schedule of Deposits already listed within that Section:

In all other respects, the Town of Grant Ordinance Relating to Issuance of Citations for Violations of Town Ordinances No. 530-2008 shall remain in full force and effect.

SECTION 4 - PASSAGE AND EFFECT

This Ordinance shall take effect and be enforced from and after its passage and posting according to law.

SECTION 5 - SEPARABILITY AND CONFLICT

If any section, subsection, paragraph, subparagraph sentence clause phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed as separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.
