RE: ELECTION WARDS

WHEREAS, Wisconsin State Statues 5.15 requires municipalities with a population of 1,000 or more to establish wards with a range of 300-1000 persons, and

WHEREAS, Portage County has advised that the adopted reapportionment plan does require the Town of Grant be divided for into Supervisory Districts # 19 and # 20.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Grant, Portage County, Wisconsin, is hereby divided into the following three (3) election wards:

- WARD 1 North Border-Southside Washington St (CTH U-90th St.) South side Elm St. (90th St.-110th St.) Southside CTH FF (110th St.-CTH F) Southside Buena Vista Rd. (CTH F-Townline Rd) With Westside 90th St. (Washington Elm St.) Westside 110th St. (Elm St. CTH FF) Westside CTH F (CTH FF-Buena Vista Rd), with West Border- CTH U (Washington St.-CTH WW) and East Border-Townline Rd. (Buena Vista Rd.-Kellner Rd.) South-border CTH WW (CTH U-CTH F), Kellner Rd. (CTH F-Townline Rd.) encompassing the census Block numbers per the attached ward report. Supervisory District # 20
- WARD 2 North Border-CTH WW (CTH U-CTH F) Kellner Rd. (CTH F- Townline Rd).

 South Border the South end of the Town of Grant in Township 21N.-R.7E, with Townline Rd. on the East and CTH U to the West, encompassing the census block numbers per attached ward report forms. Supervisory District # 20
- WARD 3 North Border-North end of Township 22N-R.7E and South Border-North side Washington St. (CTH U-90th St.)- Northside Elm St. (90th st.-110th St.)-Northside CTH FF (110th St.-CTH F) Northside Buena Vista Rd. (CTH F-Townline Rd.)- with Eastside 90th St. (Washington-Elm St.) Eastside 110th St. (Elm St.-CTH FF) Eastside CTH F (CTH FF-Buena Vista Rd.). With West Border CTH U and the East Border Townline Road /Monroe Ave., encompassing the census block Numbers per the attached ward report forms. Supervisory District # 19
- BE IT FURTHER RESOLVED, that all Town Elected Officials will be elected "at large" and not by the election wards delineated above, and
- BE IT FURTHER RESOLVED that voting in all elections shall continue to be done at one location, namely, the Grant Town Hall, and
- BE IT FURTHER RESOLVED, THAT ELECTION WARDS #1, #2, AND #3 IN THE Town of Grant shall be combined for voting purposes, except for School and Supervisory District Elections.
- BE IT FURTHER RESOLVED, that the Town of Grant Clerk shall transmit a copy of this resolution along with maps showing each ward to the Portage County Clerk within five (5) days after its passage.
